

## 220. Out of State Purchases

## Out-of-State Purchases Shipped to Texas

Due to its sales tax exemption status, Baylor University is not required to pay sales and use tax when it buys, leases, or rents taxable items that are necessary to Baylor's exempt functions when purchased from vendors located in the State of Texas. Purchases made from out-of-state vendors but shipped to a University location in Texas are also exempt from Texas sales tax. The Texas Sales Tax Exempt Certificate form and details on how to complete and use a sales tax exemption certificate are available in section 210.1.

## Out-of-State Purchases Used in Other States

Because Baylor has operations outside of the State of Texas, purchased made in other states or shipped to other states may be subject to sales tax in those states. Exemption from sales tax is determined on a state by state basis. Refer to Section 210 for requirements for claiming exemption from sales tax. The University has established exemptions in a number of states, as noted in the table which follows. In states not listed, the University is required to pay sales tax on purchases.

The Business Services Office has primary responsibility for determination of taxability of purchases and should be consulted on any questionable or unclear payments.
